

Waiver, Release of Liability, and Assumption of Risk Agreement to Participate

In consideration of being allowed to participate in the Young Yoga Masters – Kids Yoga Teacher Training, I agree to waive my rights to ordinary negligence issues, understanding that yoga includes physical movements as well as an opportunity for relaxation, stress reduction and relief of muscular tension. As is the case with any physical activity, the risk of injury, even serious or disabling, is always present and cannot be entirely eliminated.

I understand that it is my responsibility to consult my doctor regarding any physical conditions which may limit my participation in yoga class and to work within my limitations as per Doctor’s recommendations. Yoga is not a substitute for medical attention, examination, diagnosis or treatment. I am aware of the physical risks involved with strenuous exercise and understand it is my personal responsibility to consult with my Doctor regarding my participation.

I affirm that I alone am responsible to decide whether to practice the yoga poses, games or activities. I have no medical condition which would prevent me from taking part in the Kids Yoga Teacher Training, and I assume responsibility for any risk or injury I may sustain as a result of my participation.

I hereby agree to irrevocably release and waive any claims that I have now or hereafter may have against Katherine Humphrys (Aruna Santokh Kaur) and Young Yoga Masters, their agents, officers, directors, instructors, sponsors, and other participants, and the owners, lessor, and lessees of the premises as a result of my participation in any training, events or activities. Refund Policy

All requests for refunds or course transfers must be made by email to info@youngyogamasters.com. (Facebook messages, text, or voicemails will not be accepted.) Transfer fees must be paid at the time the new course date is chosen.

Refund Policy for Individual Modules

If a participant needs to withdraw their registration more than two weeks prior to the start of the Module a full refund will be given minus a \$150 registration fee. This fee is made up of a \$50 registration fee and a \$100 credit toward any future Module offered on the Young Yoga Masters schedule.

Any credits must be used within 18 months. Please note, Modules may or may not be returning to your area so you may have to travel to use the credit.

If the withdrawal takes place during the two weeks prior to the start of the course, an additional \$50 late withdrawal fee will apply.

Once the course begins, no refunds will be given.

Refund Policy for 95 Hour Children's Yoga Teacher Certification

If a participant needs to withdraw their registration more than two weeks prior to the start of the first Module a full refund will be given minus the \$150 registration fee. This fee is made up of a \$50 registration fee and a \$100 credit toward any future Module offered on the Young Yoga Masters schedule. Any credits must be used within 18 months. Please note, Modules may or may not be returning to your area so you may have to travel to use the credit.

If the withdrawal takes place during the two weeks prior to the start of the course, an additional \$50 late withdrawal fee will apply.

Withdrawal after the first Module: The registration fee paid minus \$549 will be refunded. (\$399 for first Module and \$150 registration fee)

Withdrawal after the second Module: The registration fee paid minus \$880 will be refunded. (\$730 for the first two Modules minus \$150 registration fee)

Transfer Policy:

With Two Weeks' Notice of Transfer: If a participant needs to transfer their registration to a future training more than two weeks prior to the start a \$50 transfer admin fee will be charged.

With Less than Two Weeks' Notice: If the transfer takes place during the two weeks prior to the start of the course, an additional \$50 late transfer fee will apply for a total of \$100 transfer fee.

Certification Requirements and Missed Hours

A total of 95 Hours of Training must be completed for full certification and to meet Yoga Alliance requirements of a Registered Children's Yoga School:

The 6 Weekend Modules in Toronto, Ontario, Canada consist of 95 Contact Hours and require no other training to complete the full certification.

The 12 Day Summer Certification in Burlington, Ontario, Canada consists of 95 Contact Hours and requires no other training to complete the full certification.

If a student has to miss hours due to unforeseen circumstances, they can make up those hours in the following ways:

For those taking the 95 Hour Certification – up to 8 contact hours can be made up through completing and submitting a homework assignment for review by the Faculty. Additional fees of \$108 + hst per assignment apply.

Course Cancellation Policy:

Note-June 2018: The 2018 Summer Certification has sufficient registration and will running.

Young Yoga Masters reserves the right to cancel any course that does not have sufficient enrollment. Any cancellation by Young Yoga Masters and the course hosts will be made at the time of the early registration deadline for that course.

A full refund for registration will be given in the event of a course cancellation by Young Yoga Masters or the course hosts.
